### New National Australian Disabled Parking Scheme

The Australian Disability Parking Scheme helps eligible people park nearer to their destination. The Scheme has been designed through consultations with permit holders, State, Territory and Local Government representatives and other stakeholders.

The Minister for Families, Housing, Community Services and Indigenous Affairs, Jenny Macklin, said that the Australian Disability Parking Permit will replace over 100 types of existing permits currently issued by state, territory and local governments across Australia.

“The new national scheme will operate more efficiently and give greater independence and dignity to many Australians with limited mobility who rely on existing disability parking schemes,” Ms Macklin said.

“The permit has enhanced security features, such as holograms and bar coding, which will help reduce abuse and make it easier for enforcement officers to recognise permits when people travel interstate.”

The next step in harmonising state and territory disability parking schemes will be agreement on a revised set of eligibility criteria for the permit, which is expected to be introduced in NSW in 2011.

**The Australian Disability Parking Permit will be recognised in all States and Territories.** In some States and Local Government Areas, separate parking permits may be provided for specific purposes which are not part of the Australian Disability Parking Scheme.

Australian Disability Parking Permit holders can park in reserved parking spaces and receive concessions in most public parking spaces where the sign or meter shows specific time limits. All disability parking permit holders will need to check the local rules for parking and obey all other road and parking conditions.

Existing permit holders will get the new permit in one of two ways:

1. Through the normal permit renewal process when their old permit expires, or
2. They will be mailed the new permit if their current permit is not due to expire for some time.

### Senator Jan McLucas appointed Parliamentary Secretary for Disabilities and Carers

Senator McLucas said she was pleased to have responsibility for Disabilities and Carers having worked closely with the sector previously having served as Shadow Minister for Ageing and Disabilities when in 2004, McLucas was elected by the Labor caucus to the Federal shadow ministry and was allocated responsibility for Ageing, Disabilities and Carers.. . “I look forward to re-establishing those relationships and working together in the future,” Senator McLucas said.

Senator McLucas praised Bill Shorten for the significant strides he made in the area of disability. The Labor Government instigated the Productivity Commission Inquiry into a National Disability Care and Support scheme and looks forward to receiving the report in July 2011. “The Inquiry is examining a range of options, including whether a no-fault social insurance approach to disability is appropriate in Australia,” Senator McLucas said.

“Working with Minister Jenny Macklin we will deliver on our election commitment to provide children with developmental disabilities and their carers with access to intensive early intervention services.

### Planning An Overseas Holiday For A Person With Disability

If you are helping a person with a disability planning an overseas holiday and they take medication then consider this.

### Travelling Overseas with PBS medicine

If you are planning a trip overseas, organising your medicine is one of the most important things you can do. If you or someone in your care require prescription medicine, it is important to take this medicine with you to remain in good health while you are away.

Taking or sending PBS medicines out of Australia that is not for your own personal use or the personal use of someone travelling from Australia with you is illegal.

If you are planning to take PBS medicines overseas for your own personal use or the personal use of someone travelling with you, you should:

- contact the embassy of the country you are visiting to ensure the medicine is legal there
- carry or enclose a letter from your doctor detailing what the medicine is, how much you will be taking and stating that the medicine is for your personal use
- leave the medicine in its original packaging.

There are also restrictions on the amount of PBS medicines you can take overseas. It is advisable to check with your doctor before you travel.

Customs may detain any medicine it suspects is being illegally exported. It is in your best interest to provide documentation explaining what the medicine is, how much you are carrying and that it is for your personal use.

If you are unable to get a letter from your doctor, Medicare Australia's *Medicine Export Declaration* form may be sufficient to satisfy Customs that the medicine is for your personal use. The *Medicine Export Declaration* can be found on the 'Travelling Overseas' section of the Medicare Australia website.

### Disability Terms in Other Languages

Terms like respite, group homes, advocacy and intake are often a mystery to people with a disability and their families, but people whose first language is not English have even more difficulty. To help them, and the community workers who support them, the NSW Department of Human Services has worked with the Multicultural Disability Advocacy Association (MDAA) to produce a series of factsheets which translate common disability terms into different languages. The translations provide a plain English explanation for each term and a foreign translation equivalent for 17 different languages: Arabic, Chinese, Croatian, Dri, Dinka, Farsi, Hindi, Indonesian, Korean, Macedonian, Serbian, Spanish, Turkish and Vietnamese.

### **The health of Australia's prisoners 2009**

The health of Australia's prisoners 2009 is the culmination of several years' development of national indicators in relation to prisoner health in Australia. This first national report shows that prisoners in Australia have poor health compared to the general community. A week-long snapshot of prison entrants in Australia during 2009 showed:

\* 25% had a chronic condition (such as asthma, cardiovascular disease or diabetes)

\* 81% were current smokers; 52% consumed alcohol at risky levels; and 71% had used illicit drugs during the previous 12 months

\* 37% of prison entrants reported having received a mental health diagnosis at some time; 43% had received a head injury resulting in a loss of consciousness; and 31% had been referred to prison mental health services.

The report also contains data relating to communicable diseases, educational attainment, deaths in custody, the use of health services and the types of medications used by prisoners.
